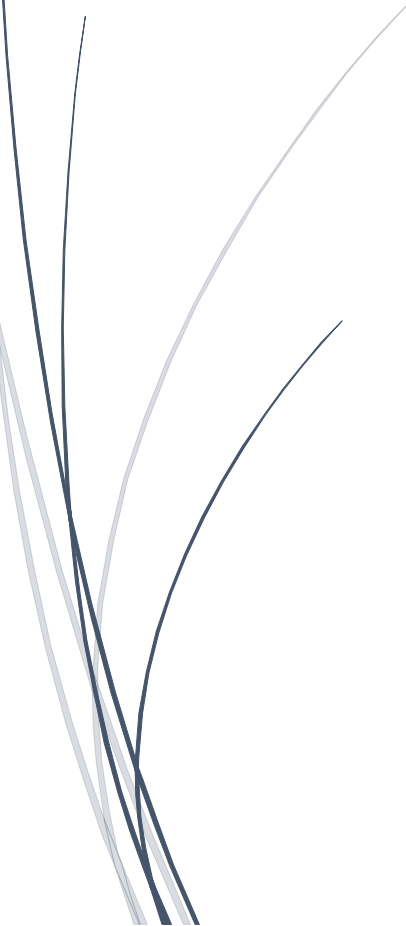

Introduction and Background

Shireland Collegiate Academy Trust was established in 2007 and founded by Shireland Collegiate Academy, an Outstanding school located in the Smethwick area. We have a reputation both locally and nationally of being innovative in our teaching methods and using technology to enhance levels of progress. We believe that everyone who passes through our doors deserves the very best that we can offer. We understand that each school is unique, but our emphases and expectations will remain the same. Nothing less than Outstanding is acceptable.

As of September 2021, the Trust family includes five primary academies, three secondary academies and two nurseries. Shireland Technology Primary in Smethwick was our first technology primary free school and Wednesfield Technology Primary will follow this same model.

Why a new Free School in Wednesfield?

Wednesfield Technology Primary will address the growing demand for primary school places in the Wednesfield area. Primary schools in the local area are unable to cope with the growing population, despite expansions over previous years. We believe every child has the right to access outstanding educational opportunities and facilities, providing high quality learning and an innovative curriculum.

We want to provide outstanding learning experiences not only to young people, but to families in the local community. Technology will be used creatively as a tool across the curriculum to support teaching and accelerate learning. We want to offer more outstanding education choices for parents, equipping their children with ambition to succeed, a rounded education, and key skills for the future.

Our Vision

Our vision is to enable pupils to achieve beyond their expectations by providing the best technology-enabled educational opportunities.

We believe that every pupil should be equipped for the future through teaching relevant skills for the world in which they live; that every pupil should have access to a 'Whole Education' underpinned by academic rigour and that each child should be safe, happy, ambitious, and respectful.

Our school environment will ensure that every child is safe and supported. We will build strong relationships with families and the local community.

Methodology of the Section 10 Consultation

The formal consultation ran for a period of six weeks between 20 September and 1 November 2021. The aims of the consultation were to engage with the Wednesfield community, obtain feedback on the Trust's plans and inform the Trust's decision about whether to enter into a funding agreement with the Secretary of State for Education to establish Wednesfield Technology Primary.

Throughout the full consultation period, a range of methods were used to engage stakeholders, including, but not limited to:

- Parents and carers
- Local residents
- Local businesses

- Local councillors
- Staff and governors from local schools

Consultation Methods and Communication Channels

Website

Social Media

- Throughout the 6-week consultation period, social media platforms were used to promote the consultation to all defined stakeholders.
- Weekly social media posts were published to promote Wednesfield Technology Primary, invite stakeholders to learn more about the school, and request them to provide feedback by completing the consultation questionnaire (please see Appendix A).
- 58% of stakeholders who completed the questionnaire stated that they learned about the Wednesfield Technology Primary and the consultation from a social media post.
- Please see Appendix D for a full record of the social media posts that were uploaded throughout the duration of the consultation.

Local Community Event

- One face-to-face community event took place at Wolverhampton Swimming and Fitness Centre on Thursday 21 October 2021.
- A total of four people directly engaged with the event.
- We were able to speak with and distribute promotional leaflets to an additional 35 people who were passing by in the venue.
- We received and replied to two emails, one from a local resident and one from a prospective parent who were not able to attend but wanted to ask questions about the school.

Leaflet Drops

- 8,504 leaflets promoting the consultation were distributed to all Royal Mail-deliverable households in the 'WV11 1' and 'WV11 3' postcode areas (please see Appendix C).

Consultation Questionnaire

- Online and paper questionnaires were used to collect feedback.
- The online questionnaire was linked on the Wednesfield Technology Primary section of the Trust website and was extensively pushed on social media and in marketing materials throughout the six-week consultation period.
- In total, 46 responses were received.

Digital Advertising

- A digital advertisement was published on the Express and Star's website to promote the Wednesfield Technology Primary consultation (please see Appendix C).
- In total, this digital banner accumulated 18,777 views.

Letter and phone calls to Stakeholders

- Businesses and community centres located on Lichfield Road were sent a letter addressing the proposed opening of Wednesfield Technology Primary and the consultation process (please see Appendix B).
- We tried on several occasions to contact the Church adjoining the school land via email and phone, but with no success. We will continue to attempt to contact the Church to update them on the plans and receive further feedback.

Outdoor banners

- Two large banners were placed on the existing school gates on Lichfield Road with permission from the City of Wolverhampton Council.
- One was focused on advertising the consultation and community drop-in event, with the other being a general banner providing contact details and information on the proposed school opening (please see Appendix C).

Newspaper Advertising

- Local newspapers were used to advertise the Section 10 Consultation over a period of one week.
- Figures 1a and 1b below highlight the print audience of each local newspapers used to advertise the Wednesfield Technology Primary Section 10 Consultation, the date of publication of the advertisement (please see Appendix C) and the approximate reach of Chronicle Week and Express & Star newspapers.

Figure 1a – Print audience statistics of the local newspaper used and the date of publication of the advertisement

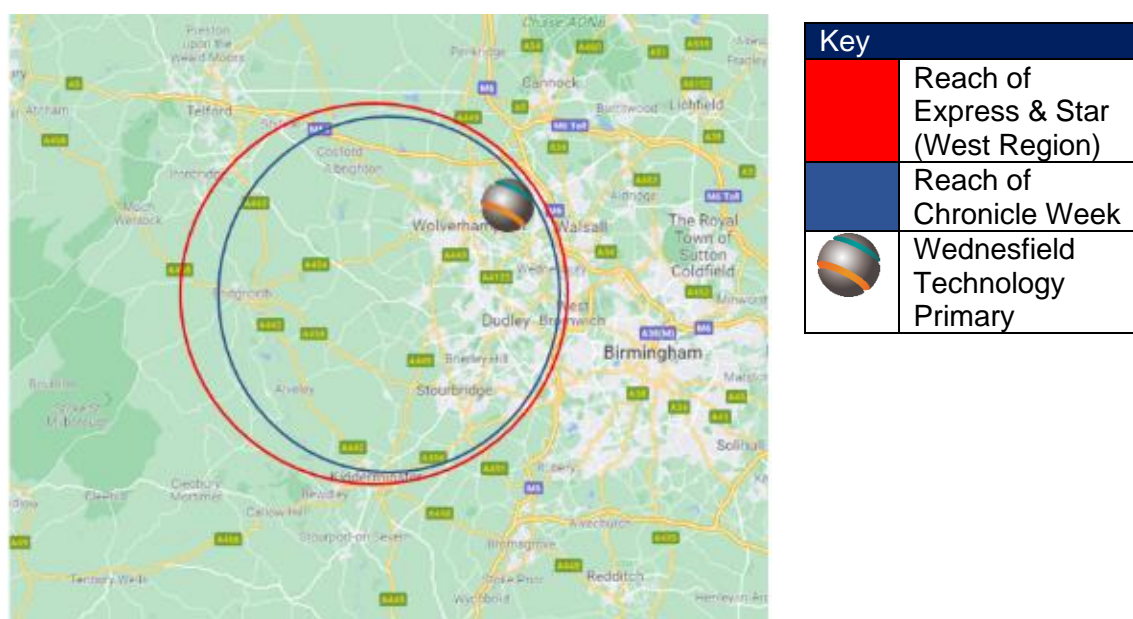
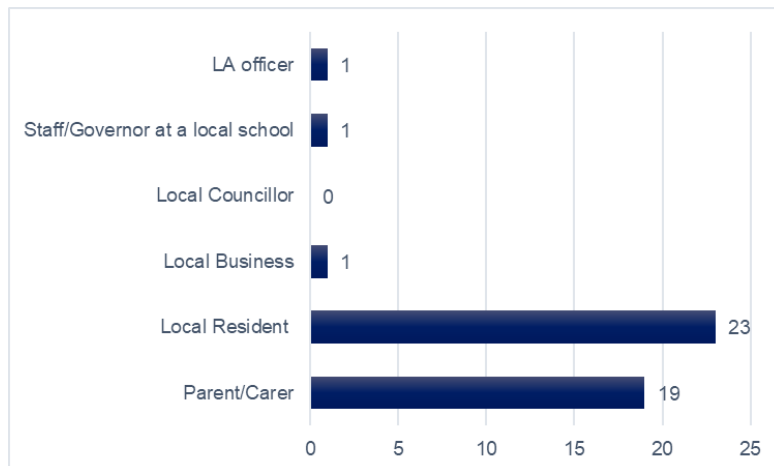


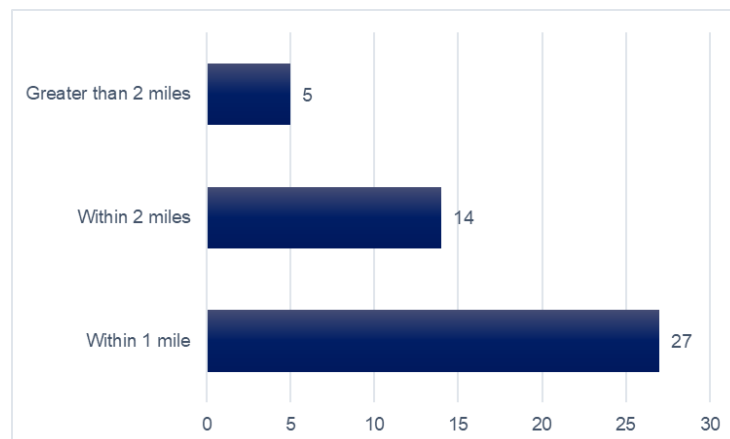
Figure 2b – Approximate reach of Chronicle Week and Express & Star newspapers

Q1 – Which of the following best describes you?

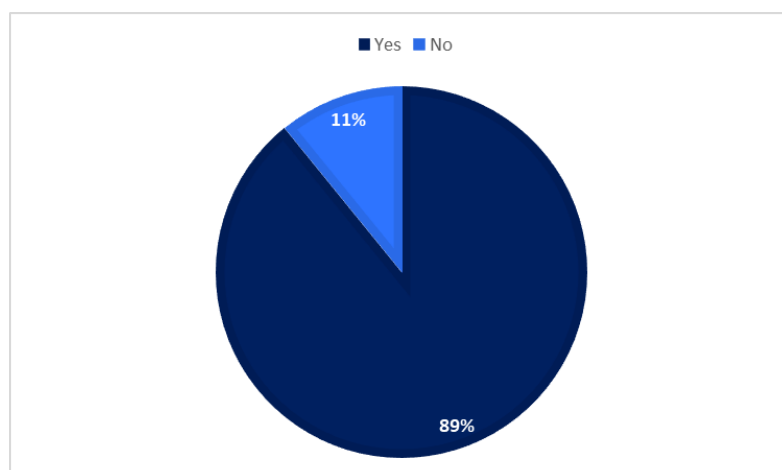


Q2 – Where do you live approximately in relation to the proposed site (WV11 1TN)?

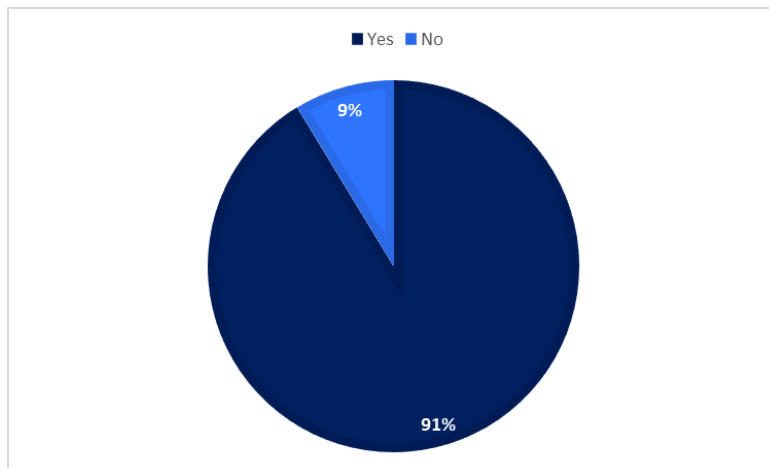


Q3 – “Wednesfield Technology Primary would enable pupils to achieve beyond their expectations by providing the best technology-enabled education opportunities”.

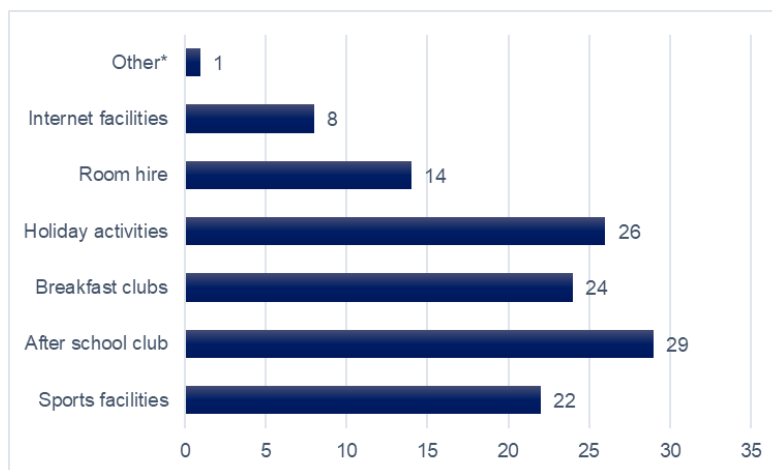
Do you agree with this statement?



Q4 - Do you agree that the opening of Wednesfield Technology Primary will help meet the need to provide additional school places in the Wednesfield area?

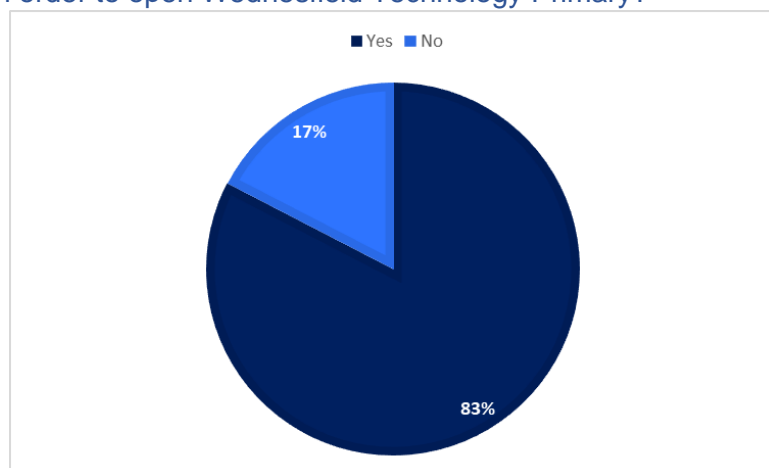


Q5 - We aim to have strong links with the community, providing a range of services. What services would you like the school to offer? (Please feel free to select more than one)

Response to feedback

Concerns of traffic congestion and parking

Strong concerns have been emphasised by stakeholders in relation to how the potential opening of the school could affect traffic congestion and parking on Lichfield Road and nearby residential streets. This is strengthened by a recent fatality in the area that local stakeholders feel could have been avoided had there been a lower speed limit enforced.

To mitigate this risk, a drive-in and drop-off point within the school grounds has been incorporated in the plans for the site. This will help reduce congestion on the main Lichfield Road and reduce the number of families parking in residential areas in the proximity of the site.

Furthermore, we are working to increase on-site parking capacity beyond that which was originally planned, and to widen the school's main entrance for easier vehicle access. We believe that this, together with the drive-in and drop-off system, will lower traffic congestion and on-street parking in the area.

We know that pick-up and drop-off are always sources of concern, which is why we constantly encourage our families to be considerate of this. Any families not adhering with this request will be spoken to appropriately.

We will continue to work closely with stakeholders to ensure that the best solution for parking and traffic is implemented for all concerned.

Concerns regarding noise when Wednesfield Technology Primary is fully operational

To reduce noise pollution when the school is fully operational, we are planning implement noise-reducing fencing that will also aid maintain privacy, which is something we must ensure from a safeguarding perspective for the children in the school.

Potential negative impact on admission numbers of schools in the proximity of Wednesfield Technology Primary

In 2016, Shireland Collegiate Academy Trust obtained authorisation from the DfE to set up a mainstream free school in the Wednesfield area and this was supported by the local authority.

At the time of approval there was a demand for primary places in the Wednesfield area, which has risen since due to increased birth-rates and further residential areas opening in the Wednesfield South Ward.

We believe that Wednesfield Technology Primary will provide further excellent education provision for families in the local area and meet this demand for primary places in the area.

Consultation Outcomes

In conclusion, there was a positive response from the local community throughout the duration of the consultation.

83% of respondents agreed that the Shireland Collegiate Academy Trust should enter into a funding agreement with the Secretary of State for Education to open Wednesfield Technology Primary.

The Trust is confident that Wednesfield Technology Primary will provide extra, much-needed spaces for local parents/guardians in the Wednesfield region, which is reinforced by the **91% of respondents who agreed that the brand-new school will help meet the demand for primary places in the region.**

Based on the responses from the consultation period, the Shireland Collegiate Academy Trust will begin the process of agreeing and entering into a Funding Agreement for Wednesfield Technology Primary with the Secretary of State for Education.

We will continue to work with stakeholders to consider any further feedback about the development of the school and address any issues and concerns that may be raised.

We would like to thank all the stakeholders that took the time to provide their feedback and engage at our consultation event.
